# New road, signs and gates for Dungeness

DF Energy bought the Dungeness Estate in 2016, which covers the iconic landscape of the fishing boats, houses, lighthouses and light railway which is also a National Nature Reserve.

As part of a process of managing the landscape, new signs are being installed and a new, more high profile entrance to the estate is being sited. This involves new gates and road speed signs to re-emphasise the messages that it is a private estate, to respect the residents' privacy, the workplace and the rules.

At the end of 2016, EDF Energy paid for a new surfacing of the estate road as well.

The energy company owns and operates Dungeness B nuclear power station adjacent to the estate and is the biggest employer in the area boosting the local economy by over £40 million each year.

Forming part of the Dungeness National Nature Reserve (NNR) and Dungeness, Romney Marsh and Rye Bay Site of Special Scientific Interest (SSSI), the estate is also of international importance forming part of the Dungeness Special Area of Conservation (SAC) as well as the Special Protection Area (SPA) because of its bird interest.

lan Stewart, Station Director at Dungeness B said: "It is important to us this unique area is protected. As a responsible landowner, EDF Energy works closely with the local community to ensure the Dungeness Estate is preserved and remains well looked after."

## Planning a photo or film shoot at Dungeness? Please read this first

he Dungeness Point is a private estate and is part of the wider Dungeness National Nature Reserve. It is very popular with tourists, birdwatchers, anglers and of course photographers, owing to its unique landscape.

To learn more about getting permission for any filming, photography or student project through any social media, please look initially at the booking website, which will help with any queries or questions you may have www.dungenessestate.co.uk.

To get permission from the Dungeness Estate for any fashion, filming or student project, the process involves paper work and an assessment of the proposed shoot before access and a permit is granted. All booked shoots, filming and student projects will be supervised Dungeness by RMCP. Any groups on the estate without the necessary permit, will be asked to leave immediately.

Breach of privacy, damage to private property, intrusion and disruption to residents across the Dungeness Estate is a frequent problem with photography shoots as well as causing damage to the

wider National Nature Reserve.

To avoid disappointment, please plan and prepare any proposed project before approaching Dungeness Estate.
